## *History*

The University Club is a premier private golf club as well as the permanent home of the LSU Men's and Women's Golf Teams. Offering members and their families a place where lasting friendships are formed, traditions are celebrated, and unforgettable memories are made.

Home of LSU Golf, The University Club features a 7,700-yard, par-72 championship golf course designed by major champion David Toms and LSU alumnus Jim Lipe. Thoughtfully crafted to challenge the game's best players while remaining enjoyable for golfers of all skill levels, the course takes full advantage of the property's natural topography and the beauty of the surrounding Louisiana wetlands.

Membership at The University Club provides access to an unmatched collection of amenities, including:

- A 7,700-yard, par-72 championship golf course designed by David Toms and LSU alumnus Jim Lipe.
- The permanent home of the LSU Men's and Women's Golf Programs.
- The largest practice facility in Louisiana, featuring four dedicated practice holes for on-course instruction.
- The University Club Golf Academy, offering professional instruction for golfers of all ages and abilities.
- A newly renovated clubhouse featuring a member's bar and grill, a fully stocked golf shop, and spacious men's and women's locker rooms.

## *Dress Code*

Proper Golf attire is required on the golf course, driving range and practice holes. Golf attire includes a collared shirt with the exception of a “mock neck” shirt commonly sold in golf shops. Denim jeans or denim shorts are not appropriate attire on the practice facility or the golf course. Shorts are permitted at any time.

## *Walking*

Walking is permitted every day. However, there is no walking for five-somes on Weekends, Holidays and "Pals Day".

## *Driving Range and Practice Area*

The Range will close at 6:30 p.m. on Wednesdays and Sundays due to the cutting of the driving range on Mondays and Thursdays. Please note that these hours are subject to change with daylight savings time changes, inclement weather, and the season.

## *Guest Policies*

A guest must accompany a member to use the facility. All guests are limited to eight rounds of golf annually. Proper Golf attire is required on the golf course, driving range and practice holes. Golf attire includes a collared shirt with the exception of a “mock neck” shirt commonly sold in golf shops. Denim jeans or denim shorts are not appropriate attire on the practice facility or the golf course. Shorts are permitted at any time.

## *Golf Academy*

The University Club Golf Academy, a state-of-the-art indoor/outdoor instructional facility located on the University Club's driving range and is the largest practice facility in the state. With four holes designated for “on-course” lessons, golfers will enjoy implementing the techniques taught during each lesson. A variety of programs are available for all levels of players, which include, private instruction with video analysis, clinics for juniors and ladies, as well as customized golf schools for corporate and individuals alike.

## *Grill*

The UC Grill has gained a reputation as a popular meeting place for lunch with business executives as well as golfers. Our relaxed atmosphere, along with lovely golf course views overlooking the newly renovated golf course, enhances your dining experience. Also, you can enjoy our new addition of a patio overlooking the 10<sup>th</sup> and 18<sup>th</sup> hole. This 1,000 square foot covered area is a great way to enjoy a wonderful meal in an unmatched atmosphere. Our menu offers a wide array of appetizers, fresh salads, gourmet sandwiches, and Clubhouse specials including Burgers, Steak, and Seafood.

Each month, the Club will mail or email my statements showing any charges due to the Club. Dues are billed on the first day of each month. Charges are due upon receipt of my statement and are considered delinquent if not paid by the 21<sup>st</sup> of the month. A late fee and finance charges will be assessed to any and all accounts not received by the 21<sup>st</sup> of the month. Members whose charges remain delinquent for 60 (sixty) days or more will have their membership privileges suspended until the account is paid in full. If the account remains unpaid beyond 90 (ninety) days, the membership will be revoked with no eligibility to transfer the membership. If my membership is terminated for delinquency, and if collection of my account requires the assistance of attorneys or a collection agency, I (we) agree to pay the additional amount due on the account, reasonable attorney and court costs, as well as any initiation fees or dues owed.
